
#### KRISTYL M. BERCKES, ESQ.

My greatest professional achievements to date have all involved taking tracts of land that have experienced decades of disinvestment and working with community



#### What is your greatest professional achievement?




#### KARI COHEN, ESQ.

#### What is your greatest professional achievement?

My greatest professional achievement is serving as the Primary Investigator on a \$1 million Small Business Innovation Research award from the National Science Foundation. I received the award when I was 26 years



old, making me one of the youngest recipients of the grant. With this funding, I was able to convert many of my team of part-time undergraduate interns into full-time employees. I can't recall ever working as hard as I did to make sure that I could hire my team and pay them what they're worth.

What types of charities or causes have you been involved with over the past three years? I am active as an Assistant Scoutmaster in Boy Scout Troop 305, Kearny NJ. Our troop draws an economically and ethnically diverse group of young scouts, all with varying levels of experience and comfort (or discomfort!) in the outdoors. I help coordinate weekly troop meetings, monthly weekend camping trips and once-yearly weeklong summer camp and high adventure trips, in addition to planning various fundraising and community service activities for the scouts. Additionally, I serve as a merit badge counselor, primarily focusing on the programming, rock climbing and entrepreneurship badges.

What works for you to ensure a work/life balance? Often, it feels like setting boundaries will lead to good mental health, but I've found the opposite to be true—good mental health is key to setting healthy work/life boundaries. Exercise, talk to a therapist and don't beat yourself up over the little things.

#### **EVAN DELGADO**

Vice President of Programs The Turrell Fund Montclair, Essex County

**Job function:** Works on the fund's strategic initiatives and policy work, oversees its grantmaking across New Jersey and Vermont and engages in direct partnerships with community partners and agencies.

#### What is your greatest professional achievement?

It has been co-leading the creation and implementation of the New Jersey Safe Babies Court Team initiative, a systems-change, racial equity-focused child

welfare initiative in which specialized support is provided for children from 0 to 3 years of age that are in foster care—or at risk of removal from their homes—and their families.

What was the best business advice you ever received? The advice from Camden residents who I interviewed as part of an ethnographic academic project a few years back was simple and powerful: that local knowledge and lived experience must be prioritized and honored when attempting to do social justice or systems change work. They pointed to the massive amounts of dollars invested in communities hard hit by financial challenges and historic injustices that too often had little impact or sometimes even caused harm due to a lack of authentic, sustained community engagement and subsequent follow through.

What inspires you to continue in your current profession? A deep-seated sense of responsibility to contribute to the effort to address societal inequities, embedded racial disparities, and the generational cycle of poverty that has been created and maintained over hundreds of years by state-sanctioned policies, laws and force. Children, families and people—especially when part of BIPOC communities—continue to be negatively impacted by these disparities, which have only been exacerbated by the ongoing public health crisis.



Attorney and Partner Laddey, Clark, & Ryan Sparta, Sussex County

**Job function:** Responsible for a team of five attorneys and several support staff members, as well as the marketing and overall growth of the firm's Personal Injury Department and oversight of its commercial and estate litigation.

What types of charities or causes have you been involved with over the past three years? I'm on the

Newton Medical Center Community Advisory Board, I'm the secretary of the Boys and Girls Club in Northwest New Jersey, I'm on the Finance Committee of St. Kateri Parish in Sparta, and I'm the chair of the Young Professionals Committee of the Sussex County Chamber of Commerce.

What mistake have you made that you learned the most from? I never worked harder or failed more in my life than the two years I spent as a teacher. I would think I had everything ready to go and be able to keep my students interested, and the lessons would sometimes fall apart right away. Those many failures, before I even became a lawyer, taught me that it's OK to fail, that it won't be the end of the world and that the next day, class, client, etc., offers another opportunity to adjust and get better.

**What works for you to ensure a work/life balance?** Remembering what's most important and trusting the people I work with.

What inspires you to continue in your current profession? I am blessed to be able to help people through some of their worst moments and give them a reason to hope that their future could be a little bit easier.




#### **DAVID DISTEFANO**

First Senior Vice President First Bank Hamilton, Mercer County

Job function: Responsible for overseeing all commercial banking activity in the market.

#### What is your greatest professional achievement?

My professional achievements resulted from a conviction about community banking at an early age. At 26, I left a prominent role at a national bank in the middle of the 2008 financial crisis to help start a local



Who has been your most influential role model? My father, David DiStefano; he is an owner of a small New Jersey-based contracting business. I started working for him at the age of 13 and learned the importance of organization, hard work, being opportunistic and leading by example. His hands-on management style and focus on a fair outcome for the customer has influenced the way I approach each day.

What types of charities or causes have you been involved with over the past three years? I am particularly passionate about volunteering and fundraising for the Children's Hospital of Philadelphia and their Beckwith-Wiedemann Syndrome (BWS) team. Our daughter, Gracie, was born prematurely with significant health challenges associated with BWS. The BWS team was instrumental at an extremely difficult time for our family during the first year of my daughter's life. In kind, our family organized a fundraiser through Alex's Lemonade Stand with proceeds dedicated to research on this rare syndrome. We were extremely proud and thankful to receive the Top Fundraiser Award from our initiative.

#### **JOHN ERRICO**

Liberty Hudson Capital Rutherford, Bergen County

Job function: Leads the firm and its affiliates, which currently have over \$5 million in residential real estate assets under management.

#### What is your greatest professional achievement?

In 2019, I began assembling funds for Liberty Hudson Opportunity Zone Fund I LLC, a qualified opportunity zone fund focusing on investing in Atlantic City's qualified opportunity zone. Not only has the fund, and its parallel

investment vehicles performed well, but, through our activities, we are tangibly improving

What types of charities or causes have you been involved with over the past three years? For the past three years, my wife and I have mentored a young man living in Passaic, New Jersey, through the Big Brothers, Big Sisters program. In addition to helping with his homework, we try to expose him to new opportunities and experiences. We've developed a deep bond with him, and are hoping to continue our mentorship with him throughout high school.

Who has been your most influential role model? My dad, who was born to a large, impoverished family in the Bronx, served in the Korean War, attended college and podiatry school, and later became a successful real estate investor and technology entrepreneur. The thing that I've taken the most from him is his boundless sense of optimism and possibility. No challenge was ever been insurmountable, and I try to embody the same mentality.







**Who has been your most influential role model?** Elon Musk has inspired me to think beyond limits. I also agree with a lot of his logic and forward thinking. He's inspired me to get out of my comfort circle and make things happen.

What types of charities or causes have you been involved with over the past three years? We absolutely love sponsoring charitable events, specially the ones that involve kids' activities that we can actually attend. Go the distance for Autism, Autism Speaks and Hayden's Heart are some of our favorites. Working with nonprofits also inspired us to start our family's CarePacks4Homeless initiative.
